- -randy has an attorney on board, available to answer questions regarding non profit statuses, etc.
- -want to ask live cam folk; will you be able to livestream the 3pm mtg tmrw? (yes)
- -action was not vindctive. actions were taken unilaterally in the groups best interest.
- -propose to break into small groups and voice concerns within group, reconvene in 10 minutes and address the GA with propositions and concerns.

- -1 group talked about rogue entity, action was arrogant to go over the heads of GA. mostly agree that instead of putting mmonmey in an umbrella group is a good idea. some group members endorse 1st unitarian.

-web team does have notes of what happened/\*maybe they'll come up with a timeline\*

-reminder: nobody was excluded from finance committee. issues at hand are being solved, tomorrow'smeeting will let us go forward in this issue. software developer will have information tomorrow in regards to this and discovery of information.

summary from group meetings:

we need Transparancy and public accounting, along with timeline of events that lead us here.

this was non-malicious intent, but process undermined occupy pdx movement general appreciation towards brian for putting a face and voice to finance committee.
